CASE STUDY

Mary and Jack are an Aboriginal elderly couple receiving the Centrelink aged pension. One of their children, Harry who is in his 40s, would come to their home every pension day and demand money from his parents. Mary and Jack love Harry very much and he is their only son, but they are also very scared of him. He often screams and swears at them and threatens to bash them if they refuse to give him money.

One day Mary and Jack discussed their concerns with their other children, and were encouraged to contact Legal Aid ACT for free and confidential advice. Mary and Jack met with one of Legal Aid's Aboriginal and Torres Strait Islander Liaison workers, who understood their concerns and supported them apply for a Family Violence Order against Harry to stop the abuse. They were also assisted with referrals to Relationships Australia for counselling and Care Financial Counselling and Community Elders support groups within their area.

WHAT IS ABUSE?

- Do you feel unsafe?**
- Is someone hurting you or threatening you?**
- Does anyone take your money?**
- Is someone calling you names, swearing or shouting at you?**
- Do you have the freedom to spend your own money?**

- Does anyone sponge off you or leave you with no money?**
- Is someone pressuring you to change where you live or who you live with?**
- Is someone refusing to let you go out and do things or stopping your contact with community?**
